

# Copenhagen Agreement - December 7 to December 18 – 2009

COP Convention Agreement – Draft (September 2009, for general distribution)

## What should come out of the conference?

- Climate agreement for the period from 2012.

## Who is taking part in the conference, and how many people?

- 192 countries will take part.

## Who is in charge?

- The COP.

## What is a COP?

- COP stands for Conference of the Parties. It is the highest body of the United Nations Climate Change Convention and consists of environment ministers who meet once a year to discuss the convention's developments.

## Why be concerned?

Voting YES for the agreement allows the COP to establish:

- An Executive Body on **Finance and Technology [Monetary System]**
- a transparent and **efficient system of governance. [Government]**

## How does it affect me?

The United States is considered a developed, not a developing country. Developed countries will be required to levy a tax that is payable to the COP as a CO<sub>2</sub> (Carbon –Dioxide) penalty for having created emissions in the past.

All developing country Parties [shall] be eligible to access financial resources... Page 128  
[Note: USA will pay, not receive]

Funds shall be allocated [to developing countries] for adaptation, mitigation, technology transfer [to developing countries] and capacity building... (Page 130)  
[Note: USA to giveaway technology?]

GDP per capita, the polluter [USA] pays [the] principle. (Page 133) at 2% [page 134]  
**\$188 billion** [annually]  
- global war on terror in the 2008 [CBS News, Jan 7.2009]

**\$288 Billion annually** in fees

- GCP per capita @2% rate.
- Consumer households 105.5 Million
- Estimated cost per household: \$2730\*

\* **Kerry-Boxer** climate bill estimates the cost per household at \$100. \$2730 - \$100 = cost recovery by “big business” in taxes, costs, etc.
